Dog/Cat Fancier's Permit

City Code Section 5-3-9 (C) – No person shall keep more than three (3) dogs or three (3) cats, over four (4) months of age, at any place, on any premises, or in any one residence, located within the City, used or occupied by human beings without first obtaining a dog or cat fancier's permit from the City. A dog or cat fancier may not in any event keep and maintain on his property more than a total of six (6) adult dogs or six (6) adult cats over the age of four (4) months.
