**1. CONTRACT DOCUMENTS/SPECIFICATIONS**

**BID BOND REQUIREMENTS: Division 1-12, Item 10 Bid Bond Requirements.** The bid bond requirement in this section was changed from 10 percent to 5 percent.

*Justification: The bid bond for the project is 5%.*

**DBE REQUIREMENT:** The DBE Goal for this project has been changed to 1.22%, to be accomplished through 0.86% Race Conscious and 0.36% Race Neutral means.

*Justification: The DBE Goal was updated for this project.*

**CONTRACTOR CERTIFICATION FOR NO BOYCOTT OF ISRAEL –** This certification has been added to Division 2 for submission with the bid. **The certification and updated Bid Proposal Checklist are attached to this addendum for use in the bidders submission.**

*Justification: This certification was added per the sponsors requirements.*

**ITEM C-100 CONTRACTOR QUALITY CONTROL PROGRAM (CQCP): Division 4-53 –** The requirement for a CQCP has been removed from this project.

*Justification: Due to the small amount of paving that will be included in this project, the requirement for the CQCP has been removed.*
