**RESIDENTIAL,

BULKY WASTES** **\$34.00 PER TON**
(FURNITURE, ETC.) **(MIN. \$5.00)**

**CONSTRUCTION,
DEMOLITION,
INDUSTRIAL,
BUILDING WASTES** **\$34.00 PER TON**
(MIN. \$5.00)

VEGETATION WASTE **\$6.00 PER TON**
(TREES, GRASS, SOD, GREEN WASTES) **(MIN. \$5.00)**

TARE/GROSS VEHICLE WEIGHTS
(PER WEIGHT TICKET) **\$5.00 PER TRANSACTION**

**MEDICAL WASTE,
ANIMAL PARTS,
CARCASSES, ETC.** **\$34.00 PER TON**
(MIN. \$15.00)

Medical waste MUST be in "red" bags, identified at scale house, and put in proper disposal area.

ASPHALT MATERIALS **\$ 5.00 PER TON**
(MIN. \$5.00)

CLEAN FILL **NO CHARGE**
(SOILS, NO DEBRIS)

GREASE TRAPS **\$15.00 PER TON**
(BULK LIQUID COOKING GREASE)

SAND/OIL SEPARATORS **\$ 5.00 PER TON**
(SUMP SAND, CAR WASH LIQUIDS, ETC.)

This category must be tested every three years, must meet TCLP 7-11 Testing Standards for disposal; documentation required.

CONCRETE MATERIAL **\$ 5.00 PER TON**
UNDER 12 INCH DIAMETER **(MIN. \$5.00)**

CONCRETE MATERIAL **\$ 8.50 PER TON**
OVER 12 INCH DIAMETER **(MIN \$6.00)**

CONCRETE MATERIAL **\$15.50 PER TON**
WITH REBAR OR METAL **(MIN. \$8.00)**

TIRES **\$133.00 PER TON**
24 INCH RIM SIZE OR SMALLER **(MIN. \$5.00)**

TIRES **\$150.00 PER TON**
OVER 24 INCH RIM SIZE **(MIN. \$10.00)**

ASBESTOS, NON-FRIABLE **\$34.00 PER TON**
(MANIFEST REQUIRED) **(MIN. \$5.00)**

ASBESTOS, FRIABLE **\$300.00 PER TON**
(MANIFEST REQUIRED, ADDITIONAL CONDITIONS) **(MIN. \$150.00)**

Friable category to meet E.P.A. standard regulations, including Wet down, double-bagged, hauled in a lined bin, special waste Manifest per load, disposed of in separate area, etc. More information is available at the Landfill Scale house.

**EQUIPMENT
STANDBY CHARGE** **\$100.00 PER HR.**
(CUSTOMER ASSISTANCE CHARGE) **(\$25.00 MIN.)**

This category is to be used for special handling requirements, such as confidential material disposal fee or insurance standby. The \$100.00 per hour fee applies per machine requested. If two machines are needed, charges will double, etc.

NORMAL DISCLAIMERS TO BE APPLIED TO THE RATE SCHEDULE, TO INCLUDE:

The City of Elko reserves the right to inspect any and all vehicles entering the Landfill and reserves the right to refuse disposal privileges of anyone at any time.

Any items identified as not acceptable for disposal will be rejected, and required to be removed by the customer who brought it in.

No Liquid Wastes accepted except those specifically listed in the Fee Schedule.

The City of Elko is not licensed to accept Hazardous Materials, except those specifically listed below:

LEAD-CELL BATTERIES, WASTE MOTOR OIL, AND ANTIFREEZE ARE ACCEPTED AT NO CHARGE FROM HOME USE CUSTOMERS ONLY. ITEMS MUST BE SEPARATED FROM OTHER WASTES AND DECLARED AT THE SCALE HOUSE.

NO COMMERCIAL USERS OF THESE WASTES WILL BE ACCEPTED!! NO EXCEPTIONS TO THIS RULE.

While the City of Elko does make allowances for these specific materials, this facility is not permitted to accept any other hazardous materials.

The City of Elko has a Program for Household Hazardous Waste to be accepted on a case-by-case basis.

Individuals are encouraged to contact the Environmental Coordinator for the City of Elko to make an appointment for disposing of this waste. This office can be contacted at 777-7213 for further information on what will be accepted. This program is for Household Waste.
