**A RESOLUTION RESTATING AND AMENDING PARKS & RECREATION FEES
PURSUANT TO TITLE 8, CHAPTER 11, SECTION 7 OF THE ELKO CITY CODE**

WHEREAS, the City Council has determined that various fees should be amended for certain Parks & Recreation Department services, and;

WHEREAS, Resolution No. 3-15 replaces Resolution No. 4-93 & No. 16-03 & No. 8-10 associated with fees for services provided by the Elko Parks & Recreation pursuant to Title 8, Chapter 11 of the Elko City Code.

NOW THEREFORE BE IT RESOLVED AND ORDERED by the City Council of the City of Elko that the following service fees be adopted as follows:

- These fees include the reservation date of the space and the designated tables located for that area.
- Events that occur over multiple days must pay a reservation fee to reserve the area for each day of the event including setup and take down.
- Events that use multiple areas of the parks will be required to reserve each area and pay a separate fee for each area that will be used for the event.


Groups of 500 or more people will be required to pay a security deposit of \$500.00. The deposit will be returned following the event if the following conditions are met to the satisfaction of the Parks Superintendent or approved designee.

- All trash in the area of use has been cleared and placed in the available receptacles. If additional receptacles will be necessary, they are to be provided by the organizer of the event.
- There is not damage to turf, trees, BBQ grills, Shelters, irrigation systems, or other amenities.
