

Upon introduction and motion by Councilman John Rice and seconded by Councilman Jay Elquist, the following Resolution and Order was passed and adopted:

Resolution No. 8-10

**A Resolution Increasing and Restating Park and Park Equipment Use Fees
Collected by the City of Elko.**

WHEREAS, the Elko City Code Section 8-11-7 provides that the City Council may, by resolution set forth fees and charges for park and park equipment use.

NOW THEREFORE BE IT RESOLVED AND ORDERED by the Elko City Council that the fees and charges for park and park equipment use be set as follows:

(1) Park Reservations:

A standard daily reservation fee of \$30 for any designated space within the parks for all groups of people.

- This fee includes the reservation of the space and four (4) tables permanently located in that area.
- Events that occur over multiple days must pay a reservation fee to reserve the area for each day of the event including setup and takedown.
- Events that use multiple areas of the parks will be required to reserve each area and pay a separate fee for each area that will be used for the event.

Groups of 200 or more people will be required to submit a Park Reservation Application a minimum of thirty (30) days prior to the event and meet with Parks Department Staff for event approval and coordination.

Groups of 200 or more people will be required to pay a security deposit of \$500. The deposit will be returned following the event if the following conditions are met to the satisfaction of the Parks Superintendent or approved designee.

- All trash in the area has been cleared and placed in the available receptacles. If additional receptacles will be necessary, they are to be provided by the organizer of the event.
- There is no damage to turf, trees, BBQ grills, Shelters, irrigation systems, or other amenities.

- (3) Mobile Bleacher Rental:

 - b. In addition to the rental fee, a delivery charge of \$1.00 per mile will be charged for each vehicle used to deliver the equipment outside the Elko city limits.
