

**CITY OF ELKO  
NEW BUSINESS AND RENEWAL LICENSE FEES**

*The business license fees for all business and professions shall be established based on the yearly gross sales receipts or revenues of the business or profession unless the rate is established by some other method. In the case of a business making sales and rendering services in the Elko City limits, the gross revenue from both sales and services shall be considered the equivalent of gross sales and pay the following fee:*

<b>\$0 - \$25,000.00</b>	<b>\$34.50 Initial fee for a new license plus \$25 Process Fee</b>
<b>\$25,001 – 50,000</b>	<b>\$55.20</b>
<b>\$50,001 – 100,000</b>	<b>\$69.00</b>
<b>\$100,001 – 200,000</b>	<b>\$103.50</b>
<b>\$200,001 – 225,000</b>	<b>\$138.00</b>
<b>\$225,001 – 250,000</b>	<b>\$172.50</b>
<b>\$250,001 – 300,000</b>	<b>\$207.00</b>
<b>\$300,001 – 350,000</b>	<b>\$241.50</b>
<b>\$350,001 – 400,000</b>	<b>\$276.00</b>
<b>\$400,001 – 500,000</b>	<b>\$310.50</b>
<b>Over \$500,001</b>	<b>\$310.50 plus \$6.90 for each full \$50,000 over \$500,001</b>

*RESIDENTIAL RENTALS, APARTMENTS, HOTELS, MOTELS, based on the amount of rentals available. The fees for a MOBILE HOME or TRAILER PARK are based on the amount of space. The initial new business fee for this type of business is based on the amount of rentals:*

<b>3 to 5 rooms</b>	<b>\$20.70 plus a \$25.00 Processing Fee for a new license</b>
<b>6 to 15 rooms</b>	<b>\$34.50</b>
<b>16 to 25 rooms</b>	<b>\$48.60</b>
<b>26 to 50 rooms</b>	<b>\$69.00</b>
<b>51 to 75 rooms</b>	<b>\$103.50</b>
<b>76 to 150 rooms</b>	<b>\$172.50</b>
<b>151 to 300 rooms</b>	<b>\$310.50</b>
<b>301 spaces or over</b>	<b>\$517.50</b>

*SOLICITORS/ PEDDLERS DISPLAYING MERCHANDISE DOOR TO DOOR:*

<b>For a period of 1 to 30 days each individual shall pay - \$103.50 +\$25 Processing Fee</b>
<b>For a period of 31 to 90 days each individual shall pay - \$207.00</b>
<b>For a period in excess of 90 days to 1 year door to door each individual shall pay \$690.00</b>

*TEMPORARY MERCHANT:*

<b>For a period of 1 to 30 days in the calendar year each applicant shall pay - \$103.50 plus a \$25.00 Processing Fee. No license will be issued in excess of 30 days within a calendar year without first securing a conditional use permit through the Planning Department.</b>

*AUCTION; AUCTIONEER LICENSE:*

*BANKS, SAVINGS AND LOAN ASSOCIATIONS AND OTHER BANKING BUSINESSES:*

Every person, entity of corporation engaged in the business of banking or savings and loan association the license fee is \$55.20 per million dollars of total average deposits or fraction thereof with a minimum of \$55.20 per bank or branch per year. A tabulation setting forth total deposits in the banks, or association on the last day of each of the previous four calendar year quarters must be submitted along with the fee. The initial fee for a new bank is \$55.20 plus a \$25.00 processing fee.

*UTILITY COMPANIES:*

\$0 – 200,000	\$1,200.00 (initial fee for a new business)
\$200,000 – 300,000	\$1,725.50
\$300,000 – 400,000	\$3,450.00
\$400,000 – 500,000	\$3,630.00
over \$500,000	\$4,200.00

*TRAVELING SHOWS:*

\$138.00 per day

*SPECIAL EVENTS VENDORS ON PRIVATE PROPERTY:*

The fee is \$6.00 times the number of days of the event, times the total number of vendors having a space or booth, who would have been required (but for the Special Events License Ordinance) to obtain a business license. No fee shall be charged for a business who holds an Elko City Business License for a business that is physically located in the City limits.

*SPECIAL EVENTS VENDORS ON PUBLIC PROPERTY:*

The fee is \$34.50 per vendor per event. No fee shall be charged for a business who holds an Elko City Business License for a business that is physically located in the City limits.

*LIQUOR LICENSE FEES: (Requires City Council approval, except special events.)*

Retail Liquor License – one bar	\$222.00 per quarter
Each additional bar, including service bar	\$117.00 per quarter
Retail Wine and/or Beer	\$117.00 per quarter
Brew Pub	\$117.00 per quarter
Wholesale Liquor	\$132.00 per quarter
Wholesale Beer and/or Wine	\$108.00 per quarter
Packaged Liquor	\$192.00 per quarter
Packaged Beer and/or Wine	\$102.00 per quarter
Fraternal, Social and Civic Club License	\$30.00 per quarter
Special Events Liquor	\$60.00 per day
Special Events Beer and/or Wine	\$24.00 per day
Caterer's Liquor License	\$60.00 per quarter

*BROTHEL LICENSE; (Requires City Council approval)*

\$3,000.00 per year can be paid semi-annually.
