Quote from my May 10, 2019 email to you:

*"In closing, I'm sorry to hear that you feel that the City does not value the relationship with you. Over the course of your contract with the City, I have had very few conversations with you about any problems regarding the relationship. We have negotiated the current and agreements in good faith, and genuinely thought things were going ok. Since the agreement expires on December 31, 2019, both parties should evaluate the status of the relationship. As always, I'm happy to meet with you to discuss."*

I received no response from you. Furthermore, despite my request that the gate be closed at night for security purposes, it has remained open.

Feel free to attend the City Council meeting on Tuesday. The decision to extend the contract is between you and the City Council, not me. However, my recommendation is that we allow the contract to expire on December 31, 2019.
